GENERAL INFORMATION PERSONAL DATA PROCESSING PURSUANT TO ART. 13

1. DATA CONTROLLER

2. DATA PROCESSED

With the establishment of the relationship, personal (name and first name, address, date of birth, no. Identity card or passport) and billing data, as well as telephone and e-mail addresses, are captured and processed. The provision of other data is optional.

3. PURPOSES OF PROCESSING

Associazione Kairòs will process the data for the fulfilment of contractual and legal obligations (administrative, tax, accounting, etc.) related to the activation of the relationship, for internal operational and management needs, for Master collaboration and taking part in shows and event organized by Associazione Kairòs, in compliance with UE REGULATION No. 2016/679.

4. DATA RETENTION PERIOD

The data will be processed for the time necessary for the execution/management of the relationship with the Data Subject in accordance with the provisions in force, and in accordance with the legal obligations related.
The data will be delated at the end of data retention period.

6. PROCESSING METHODS

The data will be processed and stored by authorized staff, whether in hard copy or telematically, with organizational modalities and logic closely related to the purposes for which they were requested and for the fulfilment of the regulations provided by law.

7. DATA DISTRIBUTION

The data will not be disclosed to third parties nor disseminated.

If reported data will be transferred to EU countries or to third countries or to an international organization, within the scope of the above mentioned purposes, you will be notified.

In addition to the Data Controller, in some cases, may have access to the data the Web Site staff, the persons who take care of the administrative and commercial part, and external staff of the Institutes provided by the Law for the contributions and taxes obligations and payment.

8. RIGHTS OF THE DATA SUBJECT

At any time the Data Subject can exercise the rights referred to in Articles 15 et seq of European Regulation no. 679/2016 and specifically: the right to know if their personal data is being processed and therefore to know its content and origin, to verify its accuracy or request its supplementation, deletion, limitation, updating, rectification, transformation into anonymous form or blocking, as well as the right to oppose in any circumstance, for legitimate reasons, its processing and to lodge a complaint with the Personal Data Protection Authority. These rights may be exercised against the Data Controller as identified above by sending an e-mail message to the e-mail address of the Data Controller.
